## Process

---

The District uses a formal competitive bid process for purchasing equipment, materials, and supplies when the cost for an item exceeds the sum of \$50,000 in a fiscal year. The District may opt to use a vendor list if the total cost in a fiscal year is less than \$50,000 but greater than \$10,000.

West Pierce Fire & Rescue utilizes the State purchasing list, MRSC Rosters, as well as Pierce County Cooperative Purchasing.
