## **Process**

The District uses a formal competitive bid process for purchasing equipment, materials, and supplies when the cost for an item exceeds the sum of \$75,000 in a fiscal year. The District may opt to use a vendor list if the total cost in a fiscal year is less than \$75,000 but greater than \$40,000.

West Pierce Fire & Rescue, for the most part, utilizes the State purchasing contracts, MRSC Rosters, as well as Cooperative Purchasing.
