STAFF REPORT

- Fourth of July incidents A/C Adams briefed the Board on the 4th of July holiday. Last year was 14 firework incidents. This year we only had 5. Firework related calls have to be confirmed with evidence of a firework. Super dry out and last year we had 58 calls this year we had 82. Five day window, last year 216 calls. This year over 300. Brush fires we have had 26 this year. Increased from last year. Great work out in the field. Jenny Weekes has been putting out a lot of messages out on social media regarding safety and burn ban information. No house fires on the 4th of July but a residential house fire on the 5th that was not firework related.
- National Night Out is August 3, 2021. A/C Adams sent an email out to all Commissioners to invite them to
 drive around the district and attend neighborhood parties. If you would like to be involved please let B/C
 Nelson know. Reply to the email and we will get you signed up. Excited to be a part of this night out. Both
 cities have parties. This year there will be about 37 parties.

 - Quarterly Report
 - Working with the City of Lakewood on Covid related funding source. D/C McCurdy is sitting on a committee to decide how to use the funds.
 - o Contract negotiations have begun with the PFSAG Guild. Great meeting this morning. Hopefully will not take long to complete the contract.
 - SS911 has had a lot of discussion regarding the 911 program office. Historically been housed in the Pierce County Government. Office needs to move to the SS911 center and keep in the central core of the county.
 - o County excise tax on phone lines goes to Pierce County. Looking at moving that into the SS911 center and start moving the whole 70 cent tax over. The County is not excited about this plan and there has been discussion amongst the Board. Moving money from one government agency to another is up for discussion. PCFCA have gone on record to support the movement of these funds. Discussion is ongoing and Chief Sharp will update as information comes available.
 - Hiring update: Currently we have under 1000 applications with 23 lateral applications. Lateral
 interviews will start next week. Written test for entry level started this week. Online test will end next
 week and interviews will follow the following the week.
 - Lobby has opened to the public and Board meetings will begin in person on August 17, 2021 at Station 31, Looking at meetings and training calendars to make sure we follow protocol on number of attendees

 Invited the Commissioners to the Eat and Greets which builds team building and gets all the divisions together. Opportunity to mingle and get to know other departments. Director Wick will send out the invites.
