# STAFF REPORT

- Chiefs Report Chief Sharp
  - Director Wick briefed the Board on the upcoming fiscal year 2020 audit. Audit will be remote. Also, briefed the Board on the opt-in program with L & I. Vulnerability assessment needs to be done and there are benefits from L & I that WPFR will receive. Details of the benefits were briefed. Director Wick will keep the Board updated on the benefits and details as information comes in.
  - Hiring update Chief Sharp commented that the lateral hiring which occurred will begin in October.
     Currently in the process of hiring 21 entry level firefighters. 175 applications will be reviewed. 75 will move on to oral board interviews. Chief Sharp complimented and thanked the hiring panels for their hard work and dedication to this hiring process.
  - SS911 budget hearing Chief Sharp briefed the Board on the budget meeting. Budget is straight forward and SS911 Directors hope to get approval soon. Fees will increase 2.6% which is cost effective.
  - Vaccination update Governor Inslee came out with the mandate of all healthcare providers to be vaccinated. Staff and the local are reviewing the proclamation and putting in place the process for our EMT's and Paramedics. Working fast to put the proclamation in place. Union President is involved with drafts and how to implement. WPFR has a high vaccination rate.
  - Interlocal Agreement between the cities of Lakewood, University Place, and the Towne of Steilacoom, and West Pierce Fire & Rescue is being implemented and put together. This is great news to WPFR & all cities as they can work to gather to provide an emergency plan for all under this umbrella.
  - A few fires have been in the district. Small brush fires that were manageable. Two structure fires in the Woodbrook area. These structures are due to be torn down soon.

WPFR was awarded an AFG grant for Wildland Urban Interface training. Grant amount is \$393,702.00.
 Trains every firefighter in the department and pays for the trainers. Very successful grant and very happy for this training.
