STAFF REPORT

- Chiefs Report Chief Sharp briefed the Board:
 - COVID report Everything is going well. Call volume is manageable and no one is out sick. Things are looking better on the COVID front.
 - Medic 21 was in an accident. Traveling routine to a call and a car came over the center line and hit them head on. All caught on video on a neighbor's video camera. Medic 21 driver and passenger were uninjured and jumped out to render aid to the driver of the car that hit the. Insurance will be coming out to take a look at the damage. Mechanics are hopeful damage can be fixed. Uninsured motorist on the car that hit the unit.
 - Events throughout the district have been cancelled but we are trying to put together something for Fall Safety Days to allow the community to receive pumpkins. Possibly a drive thru pumpkin giveaway with goodies. Prevention is working on this event and fingers are crossed that we can pull together something for the community.
 - This is the second week of hiring interviews. 750 applications and the paned is interviewing 70 people. Hope to have list together within the next week or so. Waiting for the SAFER grant to award.

Acceptance of AFG grant per Board Policy 1020- Chief Sharp briefed the Board on the policy of any
matching funds over \$200,000 needs Board approval. WPFR was granted a \$600,000 rescue vehicle
grant that will require funds of over \$200,000 to be approved. This grant replaces the old rescue vehicle
that was a donated beer truck with over 183,000 miles on it. This rescue vehicle has been asked for from
AFG for over three years and is a much needed award for a vehicle which is way past its life expectancy.
Committee will be put together to spec out and keep the cost efficient.

Chair Dalton asked for approval of Board Policy 1020. Commissioner Rankin motioned for approval. Commissioner Clancy seconded. All approved unanimously.
