STAFF REPORT

- Chiefs Report Chief Sharp
 - Review of Jamestown fire & Fort Steilacoom Park fire Chief Sharp prepared a PowerPoint presentation for both fires. Briefed the Board on all aspects of the fire and the challenges. Walked through the dispatch of both fires. Presentation was a 20 minute full review of all engines from WPFR, Central Pierce, & JBLM. Questions were answered from the Board regarding structures which were lost and the fire shift. Commissioner Sheeran asked questions regarding DNR and their policy of calling for helicopters to drop water. Chief Sharp briefed the Board on the process and the knowledge since this fire regarding DNR. Commissioner Durr commented on the investigation and collaboration with Lakewood PD. A/C Dobbs briefed the Board on the process of the fatality fire policy and investigations.
- Recent Incidents A/C Hebeisen briefed the board on recent incidents.
 - o Deck fire which started and was contained quickly. Kept to kitchen and the deck.
 - Few hours before Fort Steilacoom was a garage fire that went into the kitchen. Crews were bounced from house fires, to appliance fire and then the Fort Steilacoom fire.
 - o House fire off 92nd. Investigation still ongoing. Damaged the first row of apartments.
 - This morning 9/19 was a fire at Classi Chassis off Custer. Crews kept fire to mechanical room. Lots of smoke damage.

Replaced this ladder with the new ladder. Engine is no longer working. Hard to market ladder in this market to sell to smaller departments. Also, this has a bad motor. History tells us this will be hard to sell but will market and decision will be made at that time.

Chair Dalton called for a motion to approve Resolution # 091923-005. Commissioner Clancy motioned. Commissioner Rankin seconded. All approved unanimously.

- Commissioner Rankin Lots of news about both fires. Respected the fires and crews did a great job, and did not hear any blame, very encouraging. Brush fires are tough. Great job on this fire. Lots of fires in Spokane and the East side. Great training and good squads. Thanked B/C Bladow for calling in the necessary resources. Proud of him.
- **Commissioner Clancy** Video was very educational. Thanked Chief Sharp for the presentation.
- Commissioner Sheeran Thanked Chief for the video and was very helpful. Gave a great overview of what happened and why it happened like it did. This helps explain the way it happened and why. Chief Sharp went out to the community and walked them through verbally the challenges and helped them to understand, not a lot of push back but a lot of community that wanted to reach out and help. Speaks a lot about the Lakewood community and how they come together to help.
- **Commissioner Durr** Commented on the respect between fire & police. Very glad that the relationship is good. Appreciates the work from this department.
- Chair Dalton Dittoed the comments and great to have the crews and administration for the training. Need to make sure we continue training and keeping up with new technology. Loved to see that no matter where everyone was they worked together.
