STAFF REPORT

- Leadership Guide D/C McCurdy briefed the Board on the Leadership Guide the committee has been working on. Briefed the Board on the history of the guide. When Strategic Plan was re-vamped, they decided to redo the Leadership Guide and remove some things that were not pertinent. Included new mission statement and values. Pocket guide given to every employee. Exciting project and very glad it was complete. It is a great tool. Large versions of the guide are in every station. Chief Sharp commented on the history of the guide and how it was implemented.

- Seek to address the E-911 funding recommended moving the E911 office and all E911 funding to SS911
- Funding has been moved by the Executive, which is good, but this move has left some radio programs unsupported. To bridge the funding gap, he has proposed moving the necessary funds out of the 1/10% sales tax to fund radio systems.
- The funding of radios is not in dispute, but rather the authority of who should be able to expend the funds.
- Is it the responsibility of the Executive/Council or the BOD of SS911?

- Those of us on the workgroup strongly believe the funding agreements in place are clear in that SS911 has the authority to spend the 1/10% tax. Others agree as well.
