Chief Sharp presented them both with a Life Saving award. Commissioners and Staff congratulated and thanked Scott and Susan Bigler for their selfless act.

# **STAFF REPORT**

- Recent Incidents Chief Sharp
  - Chief Sharp briefed the Board on the incident on Monday night on I5. Crews were originally dispatched to a semi-truck that had caught on fire. While on scene they were notified that a high speed police chase was occurring in Thurston County. Within seconds the car that was being chased plowed through and hit a Tender from CPFR and a couple of State Patrol cars. Fortunately, the engine was placed out of the way of the accident and was not hit. Chief Sharp commented the scene was set up to protect the responders and all safety precautions were followed to help keep them safe. Very lucky that no responders were hurt. Passenger and Driver were transported with injuries to local hospitals.

### **ACTION ITEMS**

Resolution 111919-020 – Resolution, sole source justification to use exclusive authorized distributor –
Chief Sharp briefed the Board on the 17 new recruits that two sets of bunker gear needs to be purchased
for. The dollar amount is over the \$75K threshold and needs to be approved by the Board. This purchase
is a sole source purchase as Global is the sole source for this bunker gear. The documents were given to
the Board before the meeting to review. Action taken includes the documents needed for the auditor for
legitimate reasoning for sole source.

Commissioner Rankin commented if bringing this action to a meeting without the RFA being in the Board packet would happen often. Director Wick commented that any sole source over \$75K would require Board approval but this transaction is not the norm as this is a large class for recruit academy. Briefed the Board on the sole source process and the auditor requirements.

Chair Dalton asked for approval of Resolutions 111919-020. Commissioner Rankin motioned for approval. Commissioner Durr seconded. All approved unanimously.
