One of the switches failed and needed to be ordered by HP. Getting the hardware installed is waiting for this part. Evaluating to see if we need a larger backup to make sure this does not happen again. Generators should work within 30-45 seconds and the system was off for over 15 minutes. IT will be evaluating all the improvements needed. Station 31 is the only system affected. All other Stations are working and employees can work at an additional station to get all information needed.
