PIERCE COUNTY FIRE DISTRICT 3 WEST PIERCE FIRE & RESCUE BOARD OF FIRE COMMISSIONERS MEETING MINUTES OCTOBER 03, 2017

Chair Sheeran called the meeting of the Board of Fire Commissioners to order at 5:30 p.m. A quorum was present with Commissioner Clancy excused. Also in attendance D/C Sagers, D/C Roth, A/C Norton, A/C Tinsley, A/C McCurdy, Director Wick, Communication Relations Manager Weekes. A sign-in sheet was provided for additional attendance.

All rose for the pledge of allegiance.

APPROVAL OF AGENDA

Commissioner Dalton moved to approve the agenda. Commissioner Erb seconded. Motion approved unanimously.

PRESENTATION

- Proclamation Fire Prevention Month Community Relations Manager, Jenny Weekes provided a video on Fire Prevention and a fire escape plan for families. Video is on social media and You Tube. Great for kids and families to have a fire escape plan in place.
- B/C Adams briefed the Board on Fire Prevention week which is October 8-14th. There are 8300 kids in the school system that the Prevention Division reaches out to through their classrooms. Teachers send each kids in their class home with information on a fire escape plan and the class that has 100% of the forms returned receive an ice cream party. Great way to get kids to sit down with their families and talk about a fire escape plan.
- October 21, 2017 is Fall Safety Days at Station 21. Lots of fun for kids with free pumpkins and games.
- Prevention Grant was approved and Prevention will be targeting high risk apartments. 600 smoke alarms will be installed. Prevention also has new batteries. Prevention will be hiring a Smoke Alarm Coordinator to help with this project.
- o Chair Sheeran read the Fire Prevention Month proclamation and presented it to B/C Adams.

STAFF REPORT

- Recent Incidents A/C Tinsley
 - September 25, 2017 Crews responded to a shooting at a mobile home park. Responders found a
 male and female who had been shot. Medic units transported each of them to area hospitals.
 Investigation is ongoing.
 - A/C McCurdy reported on a house fire by Park Lodge Elementary. Homeowner was outside and when
 a firefighter approached him he stated he had set the fire. Lakewood Police were called to the scene
 and the homeowner was arrested.
- B & I Update A/C McCurdy briefed the Board on the B & I. The owner has been working with the city to get the electric work and all inspections up to code. The owners are now committed to getting the B & I reopened. The hope is to have it open on Thursday October 5, 2017.
- K & M Furniture City gave the furniture store notice that they would need to put fire sprinklers in if they were
 going to use the whole bottom floor for a furniture store. The store had only been permitted to have a portion
 used as a furniture store and for the apartments upstairs. K & M has posted that the city is putting them out of
 business. That is not a fact as the City has only wanted to them to bring the building up to code.
- Chiefs Report Chief Sharp
 - Entry level firefighter hiring Over 1000 applicants and 700 tested. Testing took place at PLU and went very well. Panel interviews will begin on October 16, 2017. Candidate reception will take place October 25, 2017. The plan is to hire 6 new firefighters. Start date will be January 2, 2017.

Chief Sharp commended the testing process and gave kudos to the system that was put in place. Recruitment and Retention Committee put new process in place and things went very smoothly.

- The Red Cross Luncheon was attended by Staff and the table was full. Red Cross has stated this
 will be their last lunch event. They are working on a new venue for next year.
- o October3, 2017 is the Caring for Kids event at the Ram.
- o Rotary event at Lakewood Theater on October 5, 2017
- o Kiwanis dinner at the Rotunda on October 7, 2017.

NEW BUSINESS

Ratification of Chief Sharp's contract – Commissioner Dalton addressed the contract and stated that he
and Director Wick had several conversations. Director Wick provided comps from several agencies.
Commissioner Dalton stated Chief Sharp's wages should be increased as the contract was negotiated at
time of merge and has not been updated. Updated the contract on vacation and cash out amounts to
vacation. Updated language so it does not mirror the contract of 1488 and provides a more detailed
contract.

Chair Sheeran asked for approval of Chief Sharp's contract. Commissioner Rankin motioned, Commissioner Dalton seconded. All approved unanimously.

BOARD COMMENTS

- Commissioner Rankin Commissioners state conference is in Spokane. Reviewed the conference and
 who will be speaking. Advised the Board that Thurston County is in the process of updating their Comm
 system. They have been in touch with Andrew Neiditz and getting information on SS911.
 Chief Sharp commented on the Chiefs meeting where the assessor spoke regarding taxes and how the
 assessed value is broken down. Briefed the Board on the School District taxes and the AV's. Lots of new
 construction going on in Lakewood and University Place.
- Commissioner Erb Great to see the B & I back open. Thanked everyone for their hard work.
- Commissioner Dalton Was impressed with the Fire Prevention video and how it will get the kids
 involved. Thanked everyone for their hard work in the community.
- Chair Sheeran Thankful the B & I is back open. Thanked A/C McCurdy for the update on K & M Furniture. The smoke alarm program will be busy will 120 installs a week. Great work with the community. Congrats to the Recruit and Retention team.

At 6:10 the meeting was adjourned for a 20 minute Executive Session.

WEST PIERCE FIRE & RESCUE QUARTERLY REPORT

3rd Quarter: July 1 – September 30, 2017

1. Major Events and Highlights

This includes all major events, highlights, accomplishments and/or awards received for the quarter.

Event / Highlight

Participated in various community events, including SummerFEST, National Night Out and the Caring for Kids Ready to Learn Fair.

A CERT class started in September with 27 participants.

The new CERT Coordinator started their 10.5 month AmeriCorps term of service.

The new Engine 32 placed in service.

Two new Chevy Volts were purchased and placed in service.

240 smoke alarms were installed in 56 homes within Lakewood and University Place.

A car seat inspection event was held in conjunction with Safe Kids Pierce County and Mary Bridge Children's Hospital at a local preschool. 36 car seats were properly installed during the event.

The new fireboat was placed in service in August.

2. Committee Work

Many internal and external committees are established and meet on a regular basis throughout the year. This section is reserved for additional committees that are doing specialized work and/or new to the District.

Committee Name

The Strategic Planning Committee started meeting and continues to meet at least monthly.

As a part of the Equity and Empowerment Initiative, the Recruitment and Retention Team brought forth numerous recommendations which were used to revise hiring practices in the Suppression Division.

3. Training

Ongoing training is managed by the Training Division throughout the year. However, specified training classes and conferences that happen outside of typical job functions are highlighted here.

Training or class

WPFR hosted a Rescue Swimmer class in September for 22 participants from fire departments around Western Washington.

Suppression and EMS personnel participated in Active Shooter training in conjunction with Lakewood Police in July.

Office365 SharePoint was rolled out and all personnel were trained on how to use the new system.

4. Community Outreach and Professional Associations

Many personnel are involved in community groups, service clubs and professional associations not only to enhance training opportunities, but for networking and building partnerships with other community oriented organizations with similar missions and goals.
