  - January 26, 2019 fire victim badly burned in an apartment fire was airlifted to Harborview. Patient was burned severely and did not survive.
  - January 27, 2019 fire on Elwood Drive. Crews did a great job knocking the fire down. Fire is still under investigation.
  - Dennys on 100<sup>th</sup> and Bridgeport Way caught fire. Denny's is an abandoned building. Still under investigation.

- Fleet update D/C Roth
  - New medic unit bid signed and came in lower than expected. Production will begin 180 days from the time they get the chassis. Committee did a great job of putting all the specs together. D/C Roth will keep the Board updated on the progress.
