- Recent Incidents A/C Boltz
 - 4th of July call volume was busy with 69 calls. 45 is average. A few brush fires with only one large fire on American Lake which started in the attic. One firefighter sustained a leg injury and crews knocked the fire down quickly
- Audit update Director Wick
 - Exit conference is scheduled and Chair Dalton will be attending. Director Wick had pre-meeting with the auditor and as previously noted in the minutes there is one finding for a procurement issue. A few suggestions were made as to some fiscal policy updates. Director Wick will be working on those suggestions regarding bid law requirements. Director Wick used an incorrect federal number on one of the grant reports and this was not a finding but was noted in the audit conference. Numbers have been corrected.
